Conditions of Swimming Pool Rental Agreement

- POOL RENTALS ARE FOR NON-COMMERCIAL, NON-PROFIT PURPOSES ONLY.
- Lifeguards are supplied by Dan's Mountain State Park.
- The swimming pool may be closed without notice due to weather, staffing limitations, or hazardous conditions. Please see the cancelation policy (reverse) for refund information.
- All patrons must follow the pool rules, which include, but are not limited to, the following:
 - **No Running.**
 - **No Diving.**
 - **No Alcohol.**
 - **No Glass.**
 - **No smoking.**
 - No swimming without a lifeguard on duty.
 - No swimming directly beneath the lifeguard chair.
 - No eating, drinking, or chewing gum while in the pool.
 - No flips, summersaults, or running starts into the pool.
 - No rough play, which includes playing chicken, dunking, pushing, or throwing others, and other unsafe acts.
 - No profanity, disorderly acts, or nudity.
 - No pets within the enclosed pool area.
 - No fires or charcoal grills within the enclosed pool area.
 - No amplified music without prior approval from park management.
 - Swim diapers or rubber pants are required for all infants and toddlers. No regular diapers.
 - Kids under the age of 13 must be supervised by an adult.
 - Additional rules may apply.

ANY VIOLATIONS OF THIS POOL RENTAL AGREEMENT MAY RESULT IN THE IMMEDIATE CANCELLATION OF THE RESERVATION AND A FORFEITURE OF ANY ASSOCIATED FEES PAID TO THE MD DEPARTMENT OF NATIJRAL RESOURCES.

I understand and agree that the use of the Dan's Mountain Pool under this rental agreement is undertaken by me solely at my own risk, and that the State of Maryland shall not be held liable for any claims, demands, actions, or causes of actions, for injuries, to me or anyone else or damage to property arising out of or connected with this Rental Agreement or the use of this pool.
