Maryland Statewide Mourning Dove Hunting Season 2016-2017

Sept. 1 - Oct. 8; Oct. 21 - Nov. 19; Dec. 17 - Jan. 7

**Statewide shooting hours: 12 Noon to Sunset during Sept. 1 - Oct. 8; area regulations may be different see below.
One half hour before Sunrise to Sunset during other season segments.**

DOVE MANAGEMENT AREA REGULATIONS: The following areas are managed by the DNR Wildlife and Heritage Service to provide food and cover for doves and other wildlife. These areas are open to the public for dove hunting. Certain restrictions apply. Fields are open only on the days and times indicated during the period Sept. 1 to Oct. 8. Areas marked with an asterisk (*) require a permit and the number of hunters may be restricted. Areas not marked with an asterisk (*) are open on a first-come basis. Acreage numbers are cumulative; some areas have multiple fields.

During the periods Oct. 21 to Nov. 19 and Dec. 17 to Jan. 17, most areas are open for dove hunting on a first come basis without additional restrictions. All Federal and State laws apply.
